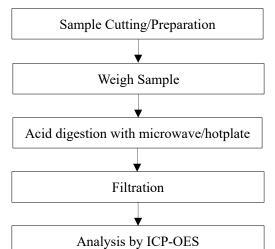

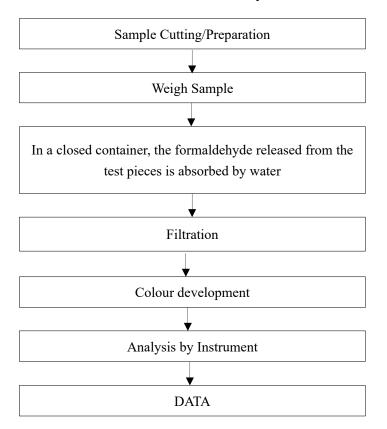

### **Test Flow Chart of Heavy Metal Content**

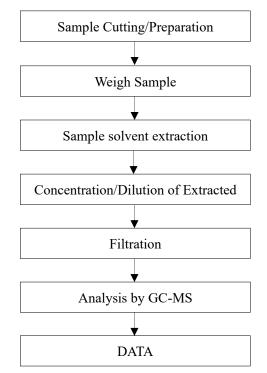




## Test Flow Chart of Formaldehyde Release
